

# Chill Cup Compliance

United States and Canada



The Silgan Containers specifications, as detailed in Appendix 1, comply with the following requirements based on knowledge of materials, manufacturing processes and supply chain documentation.

## **FDA**

The food contact materials comply with 21 CFR 175.300 Resinous and Polymeric Coatings, including migration limits of 50 ppm or less than 0.5 mg/in<sup>2</sup> of coated surface area.

## **Health Canada**

The food contact materials comply with Division 23 Section B.23.001 – B.23.008 of the Canadian Food Regulations.

## **CA Prop 65**

There are no listed substances present at levels which would require labeling.

## **BPA**

Materials are not formulated with Bisphenol-A (BPA) or Bisphenol-S (BPS).

## **Phthalates and PFAS**

Ortho-phthalates and per/polyfluoroalkyl substances (PFAS) are not used.

## **Heavy Metals**

- 1) lead, mercury, cadmium, and hexavalent chromium were not intentionally added to any material component during the manufacturing process.
- 2) the sum of any incidental concentration levels of lead, mercury, cadmium, and hexavalent chromium present in any material component does not exceed 100 parts per million by weight.
- 3) the sum of any incidental concentration levels of lead, mercury, cadmium, and hexavalent chromium present in ink or coating components does not exceed 90 parts per million by weight.
